TVA Johnsonville Fossil Plant Class II Landfill

The Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has issued a Final Permit Decision, pursuant to Rule 1200-1-7-.02(3)(i) and (j). of Tennessee's Solid Waste Program Processing and Disposal Regulations. The Tennessee Valley Authority (TVA) Johnsonville Fossil Plant has applied for a permit for construction, operation, closure and post-closure care of a new Class II landfill for the disposal of coal ash generated at the facility. The landfill, identified as IDL 43-0101, is located on the TVA reservation in Humphreys County at 535 Steam Plant Road, New Johnsonville, Tennessee, approximately 0.75 miles north of U.S. Highway 70 and 0.5 miles east of Kentucky Lake (latitude N 36°01'50"/ longitude W 87°58'45"). In accordance with Rule 1200-1-7-.02(3)(e), (f), and (g), a public comment period was designated, which ended on May 5, 2003. No public comments were received relative to this permit action. The final decision to issue the permit was made on June 17, 2003.
